FY 2014 Completed Transition and Significant Staffing Growth



FY 2014 Unprecedented Program Growth

- Almost 600 Regional Centers (RC) (an increase of nearly 230 from FY 2013)
- Nearly 11,000 Immigrant Petitions by Entrepreneur (Form I-526) (\$5.5B in potential investment)
- Used Up Visa Allocation for first time in program history (10,000)

Form I-924A Review

- 7 Regional Centers terminated for Failure to File
- 28 Notices of Intent to Terminate issued for Failing to Promote Economic Growth, all under consideration as we moved into FY 2015
- 2 Regional Centers terminated for Failing to Promote Economic Growth

Form I-924 and I-924A Public Comment

- Form I-924 and Form I-924A are currently open for public comment as of Wednesday, October 22, 2014 until December 22, 2014.

FY 2014 Program Related Statistics Increases from FY 2013

- Nearly 11,000 Immigrant Petitions by Entrepreneur (Form I-526) (+72%)
- > 270 Applications for Regional Centers under the Immigrant Investor (Form I-924) (+34%)
- > 2,500 Petitions by Entrepreneur to Remove Conditions (Form I-829) (+106%)

USCIS ELIS

Document Library

- Regional Centers upload "deal packages", that have previously approved project's documents that have been given deference
- Deal packages can be used by multiple investors with a one-page attestation document, which replaces project's deference documents, to be submitted with their Form I-526
- Reduces paperwork, can facilitate adjudication
